

# Safety clothing

**If you work** in or by the track and are within a distance of 4 meters from the track, you must always wear a two-piece suit or a boiler suit class 3 (see chart). This also applies when you work as a supervisor, a construction manager, a maintenance manager or a project manager. This also applies when you work at the road.

**WORKING** in or by the track = your attention is diverted from the moving traffic.

*In special cases* – it is accepted that you wear only a safety vest, a t-shirt or a safety jacket class 3 if your work is of short duration in and by the track, e.g. urgent call for a traffic worker to place or remove a clamp. Your supervisor/employer decides whether this option can be used.

If you work on a construction site without tracks, you must wear class 2 clothing as a minimum, unless otherwise specified. This also applies when you work as a supervisor, a construction manager, a maintenance manager or a project manager.

*The employees of Banedanmark must use the orange colored safety clothing because orange is the most visible color – also in the summer where it can be difficult to see yellow/green colors. We recommend that others do the same. Only use safety clothing that meets EN 471 or EN 20471 standards.*

**Safety footwear.** When you work in or by the track and on our construction sites, you must use safety footwear in safety class S2 as a minimum.

Employees of Banedanmark must use safety boots when working in and by the track to protect against twisting injuries in rough terrain. The same is advised at the construction sites of Banedanmark. Visitors are recommended to do the same.

If you are working in areas where safety footwear in safety class S3 is required, you will be informed by your supervisor/employer.

**If you move about** in or near the track – within a distance of 4 meters from the track, you must use a safety vest of class 2 as a minimum. If you move about during the night on unlit places, a two-piece suit or a boiler suit is recommended.

**MOVING ABOUT** in or near the track = your attention is on the moving traffic.



*During education/practice* you must use a safety vest of class 2 as a minimum. Moreover, you must be accompanied by an instructor who has passed a safety education.

Visitors at Banedanmark's track areas and construction sites must wear a safety vest in class 2 as a minimum.

- At track areas visitors must always be accompanied by an instructor who has passed a safety education.
- At construction sites visitors must be accompanied by a person who is selected by the developer.



**Safety footwear.** When you move about in or near the track there are no requirements for safety footwear, but we recommend that the conditions and the terrain is assessed before you move about. If there is a risk of twisting injuries or slips, trips or falls, your supervisor/employer can decide that safety boots are required. At Banedanmark's construction sites the information boards and instructions must be followed.
